**COMPLETING THE APPLICATION SUMMARY**

1. General Information:
  - Locality/Organization Name: List the name of the agency applying for funding.
  - Contact Person: List the name, e-mail, address, telephone and fax numbers of the person to be contacted regarding the application.
2. Project Funding:
  - CDBG Funds Requested: List the amount of CDBG funds your agency will be requesting.
  - Total Project Budget: List the entire amount (from all sources) it will cost to complete the project.
  - Identify all sources of funding for the project. Indicate whether other sources funds will be available as of 7/1/12.
3. Brief Project Description: Provide a specific description of the project that will clearly allow a reviewer to understand your project and any obvious details. Attach additional pages if necessary.
4. Project Location: Identify the specific location(s) of the project and attach a map clearly showing the specific area(s).
5. Project Begin and End: Identify the expected start and end dates of this project. *Construction projects should not exceed two (2) years. Public Service and Planning projects should not exceed one (1) year.*
6. Identify the person(s) that will be responsible for project administration.
7. National Objective: Select the correct national objective. Refer to the Eligibility Requirements section of the Application Handbook.
8. If the benefit is to low and moderate income persons, what is the total number of proposed beneficiaries and of those how many persons are low and moderate income?
9. Select how you will document benefit to low and moderate income persons.
10. If the project addresses slum and blight indicate, how you will verify?
