

**SOLID WASTE COMMITTEE

The Solid Waste Committee met on June 12, 2008 in the Committee Room, located on the second floor of the Administration Building beginning at 3:55 p.m. Mr. Kinard, Committee Chairman presided.

In accordance with the Freedom of Information Act, a copy of the agenda was sent to radio and TV stations, newspapers, and posted on the bulletin board located in the lobby of the County Administration Building.

**FY 09 DHEC Solid Waste Management Grant Award - Solid Waste Management, Dave Eger, Director** – Mr. Eger presented a request to accept the South Carolina Department of Health and Environmental Control’s 2009 Solid Waste Management Grant Award in the amount of \$39,485. No County match is required. The funds will be used to increase the collection and recycling of plastic bottles, jars, office paper and cardboard with plans to include the purchase of recycling containers, signage and educational material.

A motion was made by Mr. Derrick, seconded by Mr. Jeffcoat to recommend to full Council to approve staff’s request to accept DHEC’s 2009 Solid Waste Management Grant award in the amount of \$39,485.

The vote in favor was unanimous.

**FY 09 DHEC Waste Tire Grant Award - Solid Waste Management, Dave Eger, Director** – Mr. Eger presented a request to accept the South Carolina Department of Health and Environmental Control’s 2009 Waste Tire Grant Award in the amount of \$6,000. No County match is required. The funds will be used for the promotion of the tire recycling program and training/travel for the County’s Recycling Coordinator.

A motion was made by Mr. Derrick, seconded by Mr. Jeffcoat to recommend to full Council to approve staff’s request to accept DHEC’s 2009 Waste Tire Grant award in the amount of \$6,000.

The vote in favor was unanimous.

**FY 09 DHEC Used Oil Grant Award - Solid Waste Management, Dave Eger, Director** –

Mr. Eger presented a request to accept the South Carolina Department of Health and Environmental Control's 2009 Used Oil Grant Award in the amount of \$61,825. No County match is required. The funds will be used to improve and update the used oil recycling collection sites in the County as well as promotional items and travel/training for the County's recycling coordinator.

A motion was made by Mr. Derrick, seconded by Mr. Jeffcoat to recommend to full Council to approve staff's request to accept DHEC's 2009 Used Oil Grant Award in the amount of \$61,825.

The vote in favor was unanimous.
