SUPPORT OUR TROOPS RALLY

On Sunday, September 12, Lexington District 1 Stadium was the scene of a Rally to support our deployed troops. The field was arrayed with flags from each of the fifty states and 6 territories. A large US flag was draped from the press box. Nearly 500 people were in attendance to pay tribute to the young men and women from Lexington County currently serving on active duty.

1SG Wallace Oswald, Co. B, 122nd Engineer Battalion, from Batesburg-Leesville, was the keynote speaker. He summarized the one-year tour of duty by the unit, which recently returned from Iraq. The unit performed infrastructure enhancements and was involved in considerable explosive ordnance demolition. The company also had its share of combat with 4 Purple Hearts, 14 Bronze Stars, and numerous other awards.

Remarks were made by Senator Jackie Knotts, County Council Chairman Smokey Davis, and BG Buford Mabry, 59th Troop Commander. Jane Caughman, mother of Thomas Caughman, the young

man from Lexington killed in Iraq in June, was presented a framed Gold Star Banner by the Blue Star Mothers.

County Veterans Affairs Officer Gary Baker presented a certificate to Co. B for their outstanding service in Iraq. Retired State VA official Stan Thornburgh was presented a certificate for his service to the veterans of Lexington County.

The event kicked off with a flyover of four F16s from the 169th Fighter Wing at McEntire Air Base. Color guards from Fort Jackson and Co. B, 122nd Engineers were the centerpiece of the marching units which included ROTC units from Batesburg-Leesville HS, Lexington HS, White Knoll HS, and Wil Lou Gray Opportunity School. Contingents of Boy Scouts, Cub Scouts, and Girl Scouts also participated.

Music was provided by Constance Flemming, Hannah Nelson, Tracey Owens, Jeff Flanders and the White Knoll High School Band.

The event included a minute of silence for the victims of 9/11. Stan Thornburgh, representing the Military Order of the Purple Heart, read the names of the 21 military personnel from South Carolina who

have died in Operation Iraqi Freedom/Enduring Freedom. As each name was read, a red, white, or blue balloon was released. The event concluded with the playing of Taps.

VETERANS TRUST FUND

It's a little early to be thinking about it but income taxes will be filed starting in just three months. While poring over your income tax records and filings, consider making a contribution to the Veterans Trust Fund. You can easily make a contribution on your income tax form to designate the contribution. The amount contributed is either added to your amount due or deducted from whatever refund you may be entitled to. Directions are included on your tax form, or you can ask your tax preparer for information.

The Veterans Trust Fund provides resources to serve the needs of South Carolina's veterans by supporting programs, both public and private, for veterans. The Veterans' Trust Fund may support veteran service programs by direct funding or through donation of property or services. The Fund may supplement and augment, but shall not take the place of, services provided by state agencies.

RECORDKEEPING

Veterans or their family members must provide certain documents when filing a claim with the VA. In addition, other government organizations, such as Social Security, human resource offices, retirement agencies, etc., need copies of records for their purposes. Failure to provide those records timely can result in lengthy delays in processing a claim, paying insurance, etc.

Consider completion of the attached checklist and maintain it in a safe location where you and family members can obtain it when needed. Better yet, keep a copy in a safe deposit box or other safe location and keep a copy with your personal records.

Keep it current; make any changes expeditiously.

Maintain copies of birth and death certificates of family members, marriage licenses of all marriages, military records, bank account and investment information, and insurance policies so they can be easily obtained.

SURVIVING SPOUSE DEADLINE APPROACHES

A December 15 deadline is rapidly approaching which will affect benefit eligibility of surviving spouses of certain deceased veterans.

The VA pays Dependency and Indemnity Compensation (DIC) to the surviving spouses of service members who die while on active duty or whose death resulted from service-connected causes. Under prior law, surviving spouses who remarried at any age were not eligible for DIC unless their later marriages ended. However, the new law provides that any surviving spouse who remarried after age 57 and before December 16, 2003 have until December 15, 2004 to apply for restoration of the DIC benefit.

Applications must be received by the VA no later than December 15; any received after that date will be denied.

No application is required for a surviving spouse who remarried on or after the age of 57 after the new law was passed (December 16, 2003).

PURPLE HEART VETERANS

The Purple Heart is the nation's oldest military medal. George Washington presented the first medals in 1783. Today, there are approximately 600,000 living veterans who were wounded in combat and received the medal, according to the Military Order of the Purple Heart.

Recipients of the Purple Heart are entitled to some special State Benefits:

- Two motor vehicle license plates and special license plates - SC Dept. of Public Safety (803) 737-4000.

- Free Tuition for Certain War Veterans Children - forms may be obtained in County VA Office or Veterans Counselor at State Supported School

- *Priority group 3 at VA Medical Centers. Purple Heart Veterans don't have to make out-of-pocket payments, technically known as "co-payments" for either inpatient or outpatient VA medical services.

- *New rules in the Veterans Millennium Health Care and Benefits Act authorize VA to reimburse Purple Heart recipients for any medical co-payments made to VA for care given after November 29, 1999.

Purple Heart recipients are still responsible for making co-payments of \$7 for each 30 day supply of prescription medicine given to outpatients for conditions that are not related to military service.

SC NATIONAL GUARD UNIT DELIVERS BACKPACKS TO KIDS IN IRAQ

South-Central, Iraq – September 28, 2004 – Soldiers from the SC Army National Guard's 3-178 Field Artillery Battalion provided 85 very excited Iraqi school children with backpacks filled with school supplies near their base this weekend. Commenting on his unit's third such backpack mission, the unit's commander Lieutenant Colonel Mark King said "the 'Old Backpack 4 Iraq' program is now in full swing with schools all over the countryside opening. The intrinsic rewards of delivering the backpacks and getting our soldiers involved in the actual handing-out of the backpacks have more and more of our soldiers requesting to participate every week. These missions offer a Christmas like excitement both for the kids and our soldiers. The benefit for all is immeasurable."

The backpacks the colonel is referring to are ones his unit has collected through their unit's family readiness group, churches and various civic organizations like Blue Star Mothers of SC. The unit kicked off their "Old Backpack 4 Iraq" campaign in April. When the program began, it was King's hope that as parents in SC started buying school supplies or the 2004-2005 school year, they would consider sending their child's old backpack to his unit for the soldiers to distribute to the students in their area of operations. With logistical assistance provided by Congressman Joe Wilson's office over a thousand backpacks filled with school supplies have been delivered from throughout SC. The number is now nearing 1,500 and continues to grow. So far, the battalion's soldiers have delivered 236 backpacks to school children in their area of operations.

The battalion's Executive Officer, Major Scott Cato says his unit's civil-military affairs "Old Backpack 4 Iraq" effort "has truly been a blessing" for him. Although his combat arms field artillery soldiers have been trained to be warriors, he believes "Operation Iraqi Freedom II has provided us with a different outlook on our role as a military force. Besides supporting sustainment operations, we are also winning hearts and minds. It has made me very proud to be able to help give something back to such a poor and deprived people."

The SC Army National Guard's Lancaster-based 3-178 Field Artillery Battalion was mobilized for active duty on December 27, 2003. A number of Lexington County Guard members serve in the unit.
