Appeal Process

V eterans and other claimants for VA benefits have the right to appeal decisions made by the VA regional office, medical center or National Cemetery

Administration (NCA) office. Typical issues appealed are disability compensation, pension, education benefits, recovery of overpayments, reimbursement for unauthorized medical services, and denial of burial and memorial benefits.

A claimant has one year from the date of the notification of a VA decision to file an appeal. The first step in the appeal process is for a claimant to file



a written notice of disagreement with the VA regional office, medical center or NCA office that made the decision. This must be in writing, specifying what is being appealed and the date of the decision.



Following receipt of the written notice, VA will furnish the claimant with an appeal election letter. At this point, the claimant will need to select a traditional or non-traditional appeal process.

Traditional Appeal Process

With the traditional appeal process, the claimant can elect a hearing at the Board of Veterans Affairs (BVA)

in Washington, a BVA Video Conference hearing or BVA "in-person" hearing. The BVA video conference and BVA "in-person" hearings are conducted at the local VA regional offices. The VA will furnish the claimant a "Statement of the Case" describing what facts, laws and regulations were used in deciding the case. Along with this, a VA Form 9 will be included.

Non-traditional Appeal Process

With the non-traditional appeal process, the claimant elects to have a local hearing by a Regional Office Decision Review Officer (DRO). These hearings are held in the regional office by a DRO. The DRO will evaluate the evidence you present and make a decision on your appeal without waiting to send the case to the BVA. If you're not satisfied with the



DRO's decision, you will be sent a Statement of the Case with a VA Form 9 and your appeal then goes to the BVA.

New Drivers License Information

he South Carolina Department of Motor Vehicles (DMV) announced on the September 7, 2012, the availability of a "VETERAN" designation on driver licenses, identification cards and beginner permits for individuals who served honorably in the United States Armed Forces.

The VETERAN designation applies only to individuals who served honorably as members of the United Sates Armed Forces. To apply, Veterans must present their Form DD214 (Certificate of Release or Discharge from Active Duty), which indicates an honorable discharge. No other proof of service will be accepted. Military dependents, spouses, or civilian employees on military bases are not eligible.

The cost to add VETERAN designation to a driver license, identification card or beginner permit is \$1.00. If a customer adds the designation without changing or renewing his license, he will pay only the \$1.00 fee.

However, if the customer conducts another license transaction, he will pay \$1.00 plus the required transaction fee. For example, a customer that adds the designation when he renews his 10-year driver license would pay \$25.00 plus the \$1.00 fee. A customer who changes his address and adds the designation would pay \$10.00 plus the \$1.00 fee. Each time a customer changes or renews his credential, he must pay an additional \$1.00 fee to add the designation.

the best service in the shortest amount of time, DMV recommends that customers visit the office on Tuesdays, Wednesdays, and Thursdays. Customers should also remember that the days before and after a holiday are extremely busy at DMV.

Changes to TRICARE

TRICARE Prime enrollment fees to increase.

TRICARE Prime enrollment fees will increase for some retired military personnel and their families by 3.6 percent and for most by 17 percent starting October 1st.

TRICARE Management Activity announced July 2 its new annual fee structure for military retirees enrolled in Prime. For those who enrolled before October 1, 2011, annual fees will increase for individuals from \$230 to \$269.28, and from \$460 to \$538.56 for families



Those who enrolled after October 2, 2011, and all new beneficiaries will pay \$269.28 a year for individuals, up from \$260, and \$538.56 for families up from \$520.

The increase falls in line with legislation passed in 2011 restricting the amount the Pentagon can increase annual fees to the military cost-of-living adjustment. The TRICARE fee increases are equal to the cost-of-living adjustment in military retired pay made December 1, 2011.

Survivors of active duty deceased sponsors or medically-retired uniformed service members and their dependents are exempt from enrollment fee increases. They continue to pay the rate they paid when the survivor or medically-retired member enrolled.

Featured Medal: Iraq Campaign Medal


The Iraq Campaign Medal is a military award of the United States armed forces which was created by Executive Order 13363 of President George W. Bush on November 29, 2004. The Iraq Campaign Medal was designed by the U.S. Army Institute of Heraldry. The Iraq Campaign Medal became available for general distribution in June 2005. It was awarded to any member of the U.S. military who performed duty within the borders of Iraq (or its territorial waters) for a period of thirty consecutive days or sixty non-consecutive days. The medal was awarded retroactively from March 19, 2003 until the end of Operation New Dawn on December 31, 2011. Personnel who engaged in combat with an enemy force, or personnel wounded in combat or wounded as a result of a terrorist attack within Iraq received the Iraq Campaign Medal regardless of the number of days spent within the country.

In addition, each day participating in aerial missions as a "regularly assigned air crewmember of an aircraft flying sorties into, out of, within or over Iraq and in direct support of the military operations" established a single day of eligibility. When the required minimum days of eligibility were accrued, the medal was then awarded.

The medal was also awarded posthumously to any service member who died in the line of duty within Iraq, including from non-combat injuries such as accidents and mishaps.

On April 23, 2012, an order terminating the award of the campaign medal was issued by the Department of Defense. The order is effective to December 31, 2011, the day Operation New Dawn ended. Personnel serving in Iraq after 2011 will not be eligible to receive the Iraq Campaign Medal.





The Iraq Campaign Medal may be awarded with the arrowhead device for qualified soldiers. The Iraq Campaign Medal may be awarded with the combat operation insignia for qualified sailors assigned to Marine Corps units. The following are the established combat campaigns authorized for service stars to the Iraq Campaign Medal. On June 23, 2011 a DOD announcement closed the Iraqi Sovereignty phase and authorized an additional service star for participation in Operation New Dawn.

The medal is made of bronze and is 1.25 inches (32 mm) in diameter. The obverse depicts a relief of the map of Iraq, surmounted by two lines throughout, superimposed over a palm wreath. Above is the inscription "IRAQ CAMPAIGN." On the reverse, the Statue of Freedom surmounts a sunburst, encircled by two scimitars pointing down with the blades crossing at the tips. Below is the inscription "FOR SERVICE IN IRAQ." The medal is suspended from a ribbon 1.375 inches (34.9 mm) wide. The stripes of the ribbon are: 5/32 inch scarlet at the edges, followed by 1/16 inch white, 1/32 inch green and 1/16 inch white. The white is separated by a 5/32 inch black with a 7/16 inch stripe is chamois in the center.

The award replaced the Global War on Terrorism Expeditionary Medal for service in Iraq from March 19, 2003, through April 30, 2005. Personnel who previously received the GWOTEM for Iraq service were given the option to exchange the medal for the Iraq Campaign Medal. Both medals were not authorized for the same period of service in Iraq and any Iraq service which followed the medals creation was recognized only with the Iraq Campaign Medal.
