SALE INSTRUCTIONS FOR SUCCESSFUL 3RD PARTY BIDDERS

If you are the successful bidder at the conclusion of the sale, please follow these instructions:

- Stay seated where you are and the MIE staff will call you up one at a time to a specific location and complete your bid sheet for you.
- All **deposit and compliance checks** are to be placed in the **MIE DROP BOX** on the 2nd floor of the Lex. Co. Judicial Center **before 4:00 p.m.** When you get off the elevator take two quick rights and the box is located to the left of the phone on the wall.
- The check and especially if you have cash **must** be put in a **sealed** envelope with **Judge Spence's name and MIE Court** on the front of the envelope.
- Be sure to include the case name and case number on the check and or the envelope.
